**TERMS AND CONDITIONS**

1. The promoter of the Competition is the Australian Turf Club Limited (ABN 81 148 157 288) of Royal Randwick Racecourse, Alison Road, Randwick, NSW 2031, telephone: +61 2 9663 8400 (**Promoter**).
2. The Competition is a game of skill not chance. The Competition will be judged by a one judge selected by the Promoter (**Panel**).
3. Rules on how to enter the Competition form part of these Terms and Conditions of entry. The Rules can be found at <https://www.australianurfclub.com.au/terms-conditions/> (Website). By entering the Competition or accepting a prize, entrants agree to be bound by these Terms and Conditions.
4. The Competition will be conducted on Instagram on The Star Championships Day 1, Saturday 10 April 2021 and The Championships Day 2 – Longines Queen Elizabeth Stakes Day, Saturday 17 April 2021 between 7.00am and 4.00pm AEDT.
5. In order to enter the Competition, entrants must post a photo of themselves after a hair touch up at the STYLE With Dyson Corrale Marquee at Royal Randwick during The Star Championships on Saturday 10 April and Saturday 17 April. Photos must be posted on Instagram grid or Instagram story and must tag: @australianurfclub @dysonhair and #DysonHair
6. By posting their photo and tags as above, entrants agree to have their photo displayed on Channel 7's raceday broadcast and/or on ATC social media, and/or 7 Racing social media at the Promoters discretion.
7. Entrants must be 18 years of age or more on Saturday 10 April or Saturday 17 April and a resident of Australia. Proof of age must be provided when claiming the prize.
8. Entry to the Competition will be refused or an entrant disqualified if an entrant does not comply with these Terms and Conditions. The ATC reserves the right to verify the validity of entries and disqualify any entrant for tampering, or attempting to tamper with the entry process.
9. At the close of registration (4.00pm), the Judge will select one winner. The Winner will be announced on the raceday and notified via social media direct messaging by 12.00pm on the Monday post each raceday. There will be 1x winner per race day.
10. The prize in the Competition for the Winner each raceday is a Dyson Corrale Straightener, valued at \$699.
11. Prize value is correct as at the date of printing. The Promoter accepts no responsibility for change in prize value between the date of printing and the ultimate date on which the prize is taken.
