ATC TAB EPSOM DAY TIPPING COMP

General Terms and Conditions

1. The promoter of the ATC TAB Epsom Day Tipping Comp ('Tipping Comp') is the Australian Turf Club Limited (ABN 81 148 157 288) (Promoter).
2. Rules on how to enter the Tipping Comp form part of these General Terms and Conditions (and schedule). By entering the Tipping Comp, entrants agree to be bound by these General Terms.
3. Entry is open to all those who have registered online via the link to thegreattipoff.com portal. The link can be found via www.australianurfclub.com.au/octagonal-club/
4. In order to qualify for any winnings, each entrant must also register for the Octagonal Club via - <https://www.australianurfclub.com.au/wagering/wagering-promotions/octagonal-club/>
5. No ATC employee, official or spouse/partner may enter the Tipping Comp.
6. There is no fee to enter the Tipping Comp.
7. Each entrant may only enter the Tipping Comp once
8. This competition is a game of skill requiring entrants to finish with the highest possible total in their account based on the competition rules.
9. This event is restricted to over 18's only and contestants may be asked to provide proof of identification prior to any prizes being paid.
10. Each entrant will be given virtual dollars to the value of \$230 to wager across the day.
11. The competition runs on TAB Epsom Day, 2nd October 2021 through races 2-10. On each race, each entrant must tip \$20, with any one of those races chosen to be a 'Big Bet' race where the tip will be \$50.
12. Tips may be placed only on a pari-mutuel win, place or each way option.
13. All tips are to be placed no later than three (3) minutes prior to the start time for each race. Failure to comply with this rule will result in the tip being forfeited.
14. Once submitted, tips cannot be altered
15. Late scratchings or declaration of non runners will see the tip revert to the race favourite as per NSW TAB rules
16. Should there be two or more entrants tied on the same amount, the winner will be determined by the single largest return. If this is also the same then a continued count back will occur until the largest non-duplicate return is found. (the leaderboard will not rank according to this rule....it must be determined manually).
If none of these methods are successful in splitting the entrants, the relevant prize money will be distributed evenly between them.
19. Any entrant with an account balance greater than \$230 at the conclusion of the day will have the difference awarded to them as ATC Dollars
20. All monies won by each entrant will be paid via EFT. Cards with ATC Dollars will be distributed direct via the details on the Octagonal Club registration.

If for any reason the Tipping Comp is not capable of running as planned (including, without limitation, due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the ATC which corrupt or affect the administration, security, fairness, integrity
