'Exclusive Members Jackpot Draw' (Lucky Draw)

GENERAL TERMS

1. The promoter of the Exclusive Members Jackpot Draw is the ATC of Royal Randwick Racecourse, Alison Road, Randwick, NSW 2031, telephone: +61296638400.
2. The Exclusive Members Jackpot Draw is a game of chance and not skill and will be conducted randomly by computer selection.
3. Rules on how to enter the Exclusive Members Jackpot Draw form part of these General Terms of entry. By entering the Exclusive Members Jackpot Draw or accepting a prize, entrants agree to be bound by these General Terms.
4. Entry to the Exclusive Members Jackpot Draw will be refused or disqualified on or after the date of the Exclusive Members Jackpot Draw if an entrant does not comply with these General Terms. The ATC reserves the right to verify the validity of entries and disqualify any entrant for tampering, or attempting to tamper with the entry process.
5. Officers, management, staff and sponsors of the ATC and their immediate families are not eligible to enter the Exclusive Members Jackpot Draw.
