2. The Competition is a game of skill not chance. The Competition will be judged by a judging panel consisting of three judges selected by the Promoter (Panel). By entering the Competition or accepting a prize, entrants agree to be bound by these Terms and Conditions.
3. To enter, entrants must be present at least one of the following racedays;
