'On Top of the World' Lucky Draw (Lucky Draw)

GENERAL TERMS

1. The promoter of the Lucky Draw is the ATC of Royal Randwick Racecourse, Alison Road, Randwick, NSW 2031, telephone: +61296638400.
2. The Lucky Draw is a game of chance and not skill and will be conducted randomly by computer selection.
3. Rules on how to enter the Lucky Draw form part of these General Terms of entry. By entering the Lucky Draw or accepting a prize, entrants agree to be bound by these General Terms.
4. Entry to the Lucky Draw will be refused, or an entrant disqualified, on or after the date of the Lucky Draw if an entrant does not comply with these General Terms. The ATC reserves the right to verify the validity of entries and disqualify any entrant for tampering, or attempting to tamper with the entry process.
5. Officers, management, staff and sponsors of the ATC and their immediate families are not eligible to enter the Lucky Draw.
6. There will be a computer selection draw, in which two winning entries will be selected, which will take place on Thursday 12 October 2023 between 12.00pm and 12.30pm (AEST) at Royal Randwick Racecourse, Alison Road, Randwick, NSW 2031 (**Lucky Draw**). The winning entries will be the first and second valid entries randomly drawn from a computer database containing all valid entries. The entrant who submitted each of the two winning entries will be a winning entrant (each a **Winning Entrant**).
7. There will be two Winning Entrants announced at the Lucky Draw.
8. The ATC's decision in relation to any aspect of the Lucky Draw is final and binding. No correspondence will be entered into.
9. Entrants must be 18 years of age or more and reside in Sydney Metropolitan Area, New South Wales on the day of the Lucky Draw. The ATC may request proof of age and residential address at any time.

To be eligible for the Lucky Draw an entrant must go to www.theraces.com.au/ontopoftheworld (**Website**) and enter the Lucky Draw by following the instructions and providing all required details, including name, mobile phone number, email address and postcode and submit their entry during the Promotion Period.

14. The ATC will attempt to notify the Winning Entrants by way of a telephone call to the mobile phone number specified in the entry of that entrant.
15. The Winning Entrant must respond on that telephone call, or by a return telephone call, by 1.00pm (AEST) on Friday 13 October 2023 to officially confirm and accept their prize. If the Winning Entrant does so, they will be a Winner and receive a prize.

That entrant must respond on that telephone call, or by a return telephone call, by 5.00pm (AEST) on Friday 13 October 2023 to officially confirm and accept their prize. If that entrant does so, they will be a Winner and receive a prize.
